A. TO VOTE Mark an X in the BOX to the RIGHT of your choice(s) like this:

Article 5: To see if the Rollinsford School District will raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling \$4,869,169 (four million, eight hundred sixty nine thousand, one hundred sixty nine dollars).

Should this article be defeated, the default budget shall be \$4,851,543 (four million, eight hundred fifty one thousand, five hundred forty three dollars) which is the same as last year, with certain adjustments required by previous action of the Rollinsford School District or by law: or the governing body may hold one special meeting, in accordance with the RSA 40:13, X and XVI to take up the issue of the revised operating budget only. Budget Committee and School Board recommend.

Article 6: To see if the Rollinsford School District will vote to approve the cost items included in the collective bargaining agreement reached between the Rollinsford School Board and Rollinsford Education Association, which calls for the following increases in salaries and benefits at the current staffing levels

Teachers/Nurse	\$ 24,337	\$ 4,010	\$ 28,347
Paraprofessionals	\$ 6,816	\$ 5,704	\$ 12,520

and furthermore, to raise and appropriate the sum of forty thousand eight hundred sixty seven dollars (\$40,867) for the upcoming fiscal year such sum representing the additional costs attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels paid in the prior fiscal year.

According to RSA 273-A:12, if approved the terms of this collective bargaining agreement including the pay plan but excluding cost of living increases will continue in force and effect until a new agreement is executed. School Board recommends, Budget Committee does not recommend.
